



**Proposal  
regarding the 2025/26/2 Semester Work Plan

**I. Executive Summary**

According to Section 17 (2) of the Statutes, "the presidents of the faculty-level student unions shall perform the professional tasks of the Doctoral Student Union under the direction of the President."

According to Section 3 (1) of the Rules of Procedure of the Board of Presidents, meetings must be held at least every two months during the academic term.

In accordance with Resolution No. 21/2026 (I. 13.) of the General Assembly, the Board of Presidents must determine its own semester work plan in alignment with the semester work plan of the General Assembly.

As stated in my presidential application: "As a starting point, I propose that the Board of Presidents meets on a monthly basis, organized around specific agenda items sent in advance and substantive issues to be discussed."

**II. Draft Resolution**

1. The Board of Presidents of the University Doctoral Student Union hereby adopts its work plan for the 2025/26/2 semester as set out in the attached table.
